#### 1. LETTER OF INVITATION

The Bureau of Energy Efficiency (BEE) intends to invite Request for Proposal (RfP) (technofinancial Bid) from interested and technically qualified agencies for "Engagement of Consulting Agency for Supporting BEE for the activities under National Energy Conservation Awards (NECA) & National Painting Competition on Energy Conservation 2021".

Interested bidders may download the RfP document from the BEE website (www.beeindia.gov.in) from **05.03.2021**.

Pre-Bid Meeting will be held on 12<sup>th</sup> March 2021 at 1200 hours through Video Conference (VC). Intended bidders shall create an account on Microsoft Teams and provide the email ID of the same to Contact Person of BEE given under "General Information" of this RfP document by 1400 hours of 11<sup>th</sup> March 2021.

The bid must be submitted with Earnest Money Deposit (EMD) Declaration Form and a non-refundable Bid-document Processing fees of ₹5,000/- (₹Five Thousand only) separately in the form of Demand Draft drawn in favor of "Bureau of Energy Efficiency, New Delhi", payable at New Delhi.

The bids are to be addressed to Secretary, Bureau of Energy Efficiency, 4<sup>th</sup> Floor, Sewa Bhawan, R. K. Puram, New Delhi – 110066. The complete proposal/bid should reach by 26<sup>th</sup> March 2021 up-to 1500 hours.

#### 3. BACKGROUND INFORMATION

## (A) Energy Conservation Act, 2001

The Energy Conservation Act, 2001 (EC Act) forms the core of the legal framework put in place by India to promote energy efficiency and conservation. EC Act came into force with effect from March 1, 2002.

## (B) About BEE

The Government of India set up Bureau of Energy Efficiency (BEE) (www.beeindia.gov.in) on 1<sup>st</sup> March 2002 under the provisions of the EC Act, 2001. The mission of the BEE is to assist in developing policies and strategies with a thrust on self-regulation and market principles, within the overall framework of the EC Act, 2001 with the primary objective of reducing energy intensity of the Indian economy. This will be achieved with active participation of all stakeholders, resulting in accelerated and sustained adoption of energy efficiency in the industries, building, transport, institutions and appliances sectors.

## (C) NATIONAL ENERGY CONSERVATION AWARDS (NECA)

The NECA has been one of the important endeavors under awareness and outreach programme. To raise awareness on energy efficiency and its conservation, the BEE, under the guidance of Ministry of Power, recognizes and encourages endeavors of industrial units, institutions and establishments in reducing energy consumption by felicitating them with Energy Conservation Awards on the occasion of National Energy Conservation Day, celebrated on 14th December every year.

The awards were given for the first time on December 14, 1991, which was declared as the 'National Energy Conservation Day'. Since then, National Energy Conservation Awards (NECA) has been attracting the attention of all the stakeholders and has witnessed increasing participation level year after year. These awards are presented on EC day by eminent dignitaries and highest functionaries such as Hon'ble President, Hon'ble Prime Minister and Hon'ble Union Minister of Power.

Since 2017, awards are given on rolling cycle of three years (2017-19) i.e., every year, few sectors from Industries, Transport, Buildings, Institutions and Appliances each are considered on rotation basis.

NECA has motivated the participating units to undertake serious efforts in saving energy and environment. A summary of participation is stated below:

## (D) NATIONAL PAINTING COMPETITION ENERGY CONSERVATION

In an endeavor to bring cognizance to energy conservation at grass route level, the Ministry of Power has launched the National Awareness Campaign in the country. Painting competition for students at the School, State and at National level has been included as one of the activities of the campaign, which would not only make aware the students about the need of conserving energy but at the same time would educate and involve their parents as well in the above cause.

The competition aims to motivate children towards thinking about energy conservation, and offers them a chance to explore their creativity. In order to strengthen and for added cognizance, higher classes of 7th, 8th and 9th standards (**Group 'B'**) were introduced in the year (2013) in addition to existing classes of 4th, 5th and 6th Standards (**Group 'A'**).

The National level winners are felicitated on National Energy Conservation Day every year by eminent dignitaries.

## 4. EXISTING METHODOLOGY

## (A) NATIONAL ENERGY CONSERVATION AWARDS (NECA)

- BEE, under the guidance of Ministry of Power is responsible for organizing NECA.
- Advertisements of NECA are published in leading National Newspapers and uploaded on BEE and NECA websites.
- From 2019, applications for NECA are being invited online.
- Award Committee headed by Secretary (Power) decides the methodology, sectors, etc. and final selection of awardees for NECA.
- The Technical Committee, headed by Member (Thermal), Central Electricity Authority (CEA), assists Award Committee in finalizing the awards.
- Preliminary scrutiny of the applications is done by BEE in consultation with Evaluating Agencies and submitted to Technical Committee.
- Recommendations of the Technical Committee for Awards are placed for consideration of Award Committee for finalization of Awardees.
- Award trophies and certificates are presented to the award winners.

## (B) NATIONAL PAINTING COMPETITION ENERGY CONSERVATION

- The scheme is implemented throughout the country with the support of 11 Central Public Sector Undertakings (CPSUs') working under the administrative control of the Ministry of Power and all the 33 State Designated Agencies (SDAs).
- The Painting Competition is held in 3 stages, namely, School, State and National Level.
- Till State level, the competition is managed by Nodal Agencies and CPSUs. The National level is managed by Powergrid and NTPC in coordination with BEE.
- 1st, 2nd and 3rd prize winners of State Level Painting Competition of the Group 'A' and 'B' from each State/UT are invited to Delhi to participate in "National Level Painting Competition" which is held on 12th December.
- For finalization of awardees of National Painting Competition, a common or separate committee of experts/jury of the two groups selects paintings of each group on the day of competition itself to be considered for 1st, 2nd, 3rd and consolation prizes.
- BEE has developed the online portal (beestudentawards.in) for inviting applications online. The portal is under finalization for deployment.
- Cash prizes, laptops and award certificates are presented to the winners.

## 5. SCOPE OF WORK

The agency shall be responsible for re-designing & implementing NECA and National Painting Competition on Energy Conservation 2021. For the Painting Competition, BEE also intends to invite applications from schools outside India affiliated to CBSE/ICSE.

- The agency shall study, understand and analyze the existing schemes of NECA and Painting Competition to redesign, redevelop and implement to enhance the outreach of the programmes and increase participation.
- Agency will bring forward strategies to improve overall selection processes and provide recommendations for wider outreach.
- After redesigning, the agency will submit two proposals each for organizing NECA and Painting Competition for consideration of Competent Authority focusing on the objectives of the two events with enhanced outreach & participation.
- On finalization of the proposals, the agency shall be required to make presentation before Award Committee for approval.
- Once the proposals are approved, the agency will be responsible for implementation of NECA and Painting Competition.
- The agency shall be responsible for overall management and conduct of all of the events for activities. The implementation will include, but not limited to:
  - ✓ Development of Application Formats, Evaluation Methodology, FAQs, corresponding Online documents for portal.
  - ✓ Suitably redesign, develop, upgrade and maintain both the portals as per 'Guidelines for Indian Government Websites (GIGW)'.
  - ✓ Conduct of all the meetings related to NECA and Painting Competition for finalization
    of Award.
  - ✓ Facilitate for event management; media coverage, etc.
  - ✓ Facilitate for conduct of Award Function.
  - ✓ Detailed Reports of the events i.e. NECA and Painting Competition.
  - ✓ Any other work assigned by BEE for the above events.

#### 7. ELIGIBILITY CRITERIA

- (i) The bidder should be a company / society registered relevant Act. Must be in operation for a minimum period of 5 years i.e., FY2015-16 to FY2019-20.
- (ii) The bidder must be a National level industry body with minimum 500 nos. registered members.
- (iii) The Bidder's average turnover must be minimum ₹50.00 crores over the last three financial years viz, 2017-18, 2018-19 and 2019-20.
- (iv) Joint Ventures & Consortiums can be formed. However, the eligibility criteria have to be met by Lead Firm and work would be awarded to the Lead Firm. The Lead Firm would be responsible for the assignment.
- (v) In order to facilitate time bound activity, the bidder must have an established Set up / Support Center in Delhi / NCR.
- (vi) The bidder must be registered with Goods and Services Tax (GST) & provide the same.
- (vii) The bidder must have minimum 10 years' experience of working with industry sectors.
- (viii) The bidder should have minimum 5 years' experience in the field of Energy Efficiency and Energy Conservation projects.
- (ix) The bidder must have organized at least 3 similar events at National Level in the last 5 financial years i.e., 2015-16, 2016-17, 2017-18, 2018-19 and 2019-20.
- (x) The team should comprise of the following:
  - a) 1 No. Team Leader
  - MTech / MBA with minimum 15 years of experience with industries

- Should have led a team for organizing at least one National level award competition
- b) 2 Nos. BEE certified Energy Auditors/Energy Managers
- BE / BTech with minimum 10 years' experience in industry out of which minimum 5 years' experience in energy efficiency
- c) 2 Nos. Technical Professionals
- BE / BTech with minimum 5 years' working experience
- d) 1 No. IT Expert
- BE / BTech in Information Technology or Computer Science with minimum 10 years' experience in design, development and maintenance of dynamic portals.
- e) 1 No. Media Expert
- Degree or PG Diploma in Media or related subject with minimum 5 years' experience working with government agency / departments and having handled such National events.
- (xi) The team shall be full time available at BEE's discretion till the completion of the work. No change in team members is permitted without the permission of BEE.
- (xii) The bidder must not have been blacklisted by a Central / State Government institution and there has been no litigation with any government department on account of services. The bid will be rejected straightway without assigning any reasons if the bidder is involved in any criminal cases, declared black listed by any Govt./Semi govt. department/agencies etc.

## 8. EVALUATION AND SELECTION PROCEDURE

- (1) Compliance with the minimum eligibility criteria given in Section 7 & documents in submitted as per requirement of RfP will be evaluated first by the Bid Opening Committee (BOC). The technical bids of those bidders who do not fulfill the minimum eligibility criteria and / or documents not in order will not be evaluated and will be disqualified.
- (2) The Price Bid of the technically qualified bidders will be opened on "(**To be announced date & time**)" through Video Conferencing. The intended bidders may participate through VC in the Price Bid opening on announced date & time.
- (3) Bidder shall submit the price bid clearly indicating the cost of services in both figure and words, in INR.
- (4) In the event of any difference between figures and words in quotation, the lower of the two shall be taken into account.
- (5) The amount indicated in the financial proposal shall be without any condition attached or subjected to any assumption and shall be final and binding. In case any assumption or

- condition is indicated in the financial proposal, it shall be considered non-responsive and liable to be rejected.
- (6) The bids shall be compared on the basis of total lump-sum firm bid price for the entire scope of work as defined in the RfP document.
- (7) Evaluated bid prices of all the bidders shall be compared among themselves to determine the lowest evaluated bid and as a result of these comparison; the lowest bid may be considered for award of contract.
- (8) L1 bidder would be selected based on Amount (Excluding GST)

#### 9. INSTRUCTIONS TO BIDDERS

(i) The bidders shall prepare and submit original each of the document

**Envelope 1: Technical Bid Envelope 2: Financial Bid** 

clearly mentioning as original on the document as well as on envelop.

- (ii) Bid processing fees, covering letter, documents supporting eligibility criteria and forms, with information in desired formats, shall be enclosed in Envelope 1.
- (iii) Each page of bid document & enclosures shall be signed by the bidder and seal affixed. In case of any corrections / alterations in the bid document, the bidder should attest the same; otherwise bid may not be considered.
- (iv) All the above two envelopes shall be put in another envelope and sealed. This envelope should be marked "Bids for Hiring Agency for NECA & National Painting Competition 2021" and addressed to Secretary, BEE.
- (v) Any bid received by the BEE after last date and time of submission of bids will not be accepted and the same will be rejected. BEE shall not be liable to be responsible for postal delays or non-delivery at BEE's office.
- (vi) The successful bidder will have to furnish a refundable **Performance Security of 3%** of the total value of the job awarded by a Bank Guarantee along with agreement on ₹100/- Non-Judicial stamp paper within 7 days after receive of letter of Award. The Performance Security shall be returned on completion of the project to the satisfaction of BEE.
- (vii) In case the bidder who has been awarded the contract refuses to accept the contract issued by the BEE or fails to respond to the letter of award of work by the BEE in 7 days' time or backs out after acceptance or violates any of the conditions prescribed in RfP document, then they will be suspended for a period of one year and / or other action as decided by competent authority of BEE.
- (viii) In the event, if the successful bidder is found performing job below the set-out quality standards as stated in work order, it shall be lawful for BEE, in its discretion, to remove or withhold any part of job until the job is found satisfactory. The BEE reserves the right to deduct amount from the contract amount for deficiency/incomplete services & the amount shall be decided by competent authority of BEE.
- (ix) In the event of the any finding of error or defect due to the fault of successful bidder at any time after the delivery, the successful bidders shall be bound, if called upon to do so, to rectify such error or defect at his own cost to the satisfaction of and within the time fixed by the BEE.

#### 10. PAYMENT TERMS & SCHEDULE

- (i) Payment authority will be Bureau of Energy Efficiency.
- (ii) The Agency shall raise the invoice in favor of "The Secretary, Bureau of Energy Efficiency, 4th Floor, Sewa Bhawan, Sector 1, R. K. Puram, New Delhi".
- (iii) The payment may be considered, after deductions if any, on receipt of invoice from the agency on **completion of deliverables** as stated below:

- (iv) Deductions for non-deliverables shall be decided by competent authority of BEE and shall be binding on the bidder
- (v) For any unforeseen reason, if competent authority decides to cancel/ suspend the activities, the payment to agency shall be made on pro-rata basis for the activities completed/ undertaken by the agency till that date, as decided by BEE, which shall be final and binding on all concerned.

#### 11. DEFINITION OF TERMS

- (i) "Contract" means the agreement entered into by the BEE and successful bidder as per the contract agreement signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- (ii) "Owner" means Bureau of Energy Efficiency (BEE), 4<sup>th</sup> Floor, Sewa Bhawan, R. K. Puram, New Delhi 110 066 and shall include their legal representatives, successors and assigns.
- (iii) "BEE" means the Bureau of Energy Efficiency (BEE), a statutory body under Ministry of Power, Government of India having its office at 4<sup>th</sup> Floor, Sewa Bhawan, R.K. Puram, New Delhi 110 066.
- (iv) The "Agency" shall mean the bidder whose both technical and price bid will be accepted by the BEE for award of the Work and shall include such successful bidder's legal representatives, successors and permitted assignees.
- (v) The term "Contract Price" shall mean the lump-sum firm price quoted by the agency in his bid with additions and/or deletions as may be agreed and incorporated in the letter of award, for the entire scope of Work.
- (vi) "Notification of Award of Contract" / "Letter of Award" shall mean the official notice issued by the BEE notifying the agency that his bid has been accepted.
- (vii) "Date of Contract" shall mean the date on which notification of award of contract / letter of award has been issued.
- (viii) "Work" shall mean and include re-designing & implementing National Energy Conservation Awards 2021 (NECA 2021) and National Painting Competition on Energy Conservation (NPCE 2021) as per agreed specifications defined in the contract.

#### 12. CONFLICT OF INTEREST

The agency who is selected for the work will have to maintain the confidentiality of the information compiled. In no case the agency would be allowed to use the data or share the information with anyone else, except for the BEE. The BEE shall hold the copyrights over any of the data collected or compiled during the course of the awards.

## 13. FORCE MAJEURE

Shall mean and be limited to the following:

War/hostilities, Riot or Civil commotion, Earthquake, flood, tempest, lightening or other natural physical disaster and restrictions imposed by the Government or other statutory bodies which prevents or delays the execution of the Contract by Consultant.

In the event of any force majeure cause, agency or BEE shall not be liable for delays in performing their obligations under this order and the completion dates may be extended, for a period not exceeding the period of delay attributable to the causes of Force Majeure. Neither BEE nor agency shall be liable to pay extra costs provided it is mutually established that Force Majeure Conditions did actually exist. The agency shall at all times, indemnify and keep indemnified, BEE and its officer's servants and agents, from and against all/any claims whatsoever, arising as a consequence of, or in the course of execution of the work (including but not limited to property loss and damage, personal accident, injury or death of or to property or person, of the consultant or any JV partner or sub-contractor, and / or the servants or agents of the consultant, or any other JV partner or any sub contractor and / or of the BEE).

## 14. DISCLAIMER

BEE and/or its officers, employees disclaim all liability from any loss or damage, whether foreseeable or not, suffered by any person acting on or refraining from acting because of any information including statements, information, forecasts, estimates or projections contained in this document or conduct ancillary to it whether or not the loss or damage arises in connection with any omission, negligence, default, lack of care or misrepresentation on the part of BEE and/or any of its officers, employees.

#### 15. AMENDMENTS TO RFP

At any time prior to the last date for receipt of bids, BEE, may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the RfP document by an amendment. In order to provide prospective bidders reasonable time in which to take the amendment into account in preparing their bids, BEE may, at its discretion, extend the last date for the receipt of Bids and/or make other changes in the requirements set out in the Invitation for RfP.

#### 16. RESOLUTION OF DISPUTES

- (i) BEE and the agency shall make effort to resolve amicably by direct informal negotiations on any disagreement or dispute arising in connection with the contract.
- (ii) The decision of Director General, BEE, shall be final and binding on both the parties.
- (iii) For any arbitration proceedings, agency will pay the cost and expenses of arbitration proceedings & shall be held at Delhi.
- (iv) The laws applicable to the contract shall be the laws in force in India. The courts of Delhi only shall have exclusive jurisdiction in all matters arising under this contract.
