Dear Sir/Madam

With reference to the amendment of the Energy Conservation Act in December 2022, Ministry of Power (MoP) through **Gazette Notification dated 20th Oct'2023**, has **specified following** minimum share of consumption of renewable energy by electricity distribution licensees (DISCOMs) as a percentage of total share of energy consumption, **effective from 1st April 2024:**

Through the Gazette notification referred above, **BEE has been entrusted with the responsibility of maintaining data and ensuring compliance** of renewable energy utilization by the designated consumer(s) and submit report to the Central Government.

In this regard, DISCOMs are requested to submit the above **progress to the compliance information for 3 quarters of FY 2024-25** i.e. till Dec 2024 in the enclosed format **on or before 10th Feb'2025**, through email on "nikhil.prasad@beeindia.gov.in". Clarification (if any) on the above may also be sent on this email.
