## NATIONALENERGY CONSERVATION AWARD – 2016 AWARD FOR BEST FINANCIAL INSTITUTION

### Award for Excellence in FinancingEnergy Conservation Projects

#### **OBJECTIVE**

To honour the efforts and contribution of those Financial Institutions (Banks/NBFCs) who have encouraged the investors by financing the energy efficiency projects and assisted in development of sustainable business models.

### THE AWARDS

First and second prizes are proposed to be given to the Management of the Financial institutions in the form of a Silver Plaque with appropriate citation on such awards as may be decided by the Ministry of Power. The performance of the Financialinstitutions would be judged through a questionnaire (format enclosed) which would be evaluated by an Award Committee.

The Award Committee would take a final decision on the number of awards depending on the number and quality of entries received in each category. It is not necessary to give First and Second award in each category.

#### **ELIGIBILITY**

- 1. The scheme is open to all public as well as private FIs including Banks and NBFCs, registered with RBI.
- 2. The energy efficiency projects financially supported by FIs shouldhave at least completed one year so that necessary documents like repayment status and energy audit reports could be submitted.
- 3. FI who is involved in financing the project which seeks to achieve demonstrable energy savings and mitigation in emission of green-house gases is eligible.
- 4. FI who has financed the projects in sectors covering Government Building / CommercialBuilding/ Residential Building/Municipalities/Industries/MSMEs/DSM projects is eligible.

### **CRITERIA FOR JUDGING MERIT**

- a) The Award Committee will decide the recipient of the awards on the basis of outstanding achievements and contribution in the field of financing of energy efficiency, conservation and management projects, which will be based on the evaluation strategy attached at **Annexure-B**.
- b) The award committee will analyze the entries and the decision of the committee would be final and no appeal would be entertained.
- c) The members of the Award Committee or their nominees may invite participating PFI to Delhi for verification of data supplied, if felt necessary and it will be obligatory on the part of the participating units to provide necessary co-operation to the committee. The expenditure in this regard is to be borne by PFI only.
