CLARIFICATIONS TO BIDDERS

- EVSE equipment shall come with a comprehensive onsite warranty and AMC of at least 3 years from date of installation and commissioning. All EVSE equipment shall have a design life of at least 10 years.
- 2. Selection of bidders shall be solely based on (L-1), (L-2) and (L-3) prices of EVSE equipment discovered through this Bidding process. Criteria for bid evaluation will be compliance of the EVSE equipment specifications submitted by the bidder with the minimum technical specifications and other requirements for EVSE equipment specified in the revised MoP guidelines issued on 1st October 2019. Additionally, EVSEs under this bid shall mandatorily meet the Bharat charger (AC001 and DC001) specifications.
- 3. Terms of payment
- **Delivery of EVSE**: 80% of the payment upon receipt of the contracted quantity of EVSE by authorized representative of BEE or by any other entity authorized by it.
- Installation and commissioning of EVSE: Scope of installing & commissioning would cost:
 - Connecting the EVSE to the power and earthing outlets provided at the charging station.
 - Ensuring that all the safety regulation are meet as laid out by CEA, MoP and other government agencies.
 - Providing smart connectivity to the EVSE, so that the charge point operator (CPO) and connect and control the EVSE via some application (App/Website/other software).
 - The other installation and commissioning cost as per bidder experience.
 - Cost for trenching and laying cable should be quoted as INR per Meter.
 - Number of distribution box to be installed are as per the minimum number of EVSE as inscribed in EOI issued by DHI.
