The Bureau of Energy Efficiency (BEE), a statutory body under Ministry of Power, Government of India, is executing a project "Financing Energy Efficiency at MSMEs" which is a part of the Global Environment Facility (GEF) Programmatic Framework for Energy Efficiency in India. The GEF implementation agency for this project is the World Bank. The project is being jointly executed by BEE and Small Industries Development Bank of India (SIDBI).

The objective of this project is to increase the demand for energy efficiency investments in Micro Small and Medium Enterprise (MSME) clusters in certain identified sectors. The work as envisaged under the project has already been completed at the MSMEs located in the clusters around Pune, Kolhapur, Ankleshwar, Tirunelveli, Faridabad, Ludhiana, Varanasi, Dehradun, Thane and Delhi-NCR, and benefits have accrued to these industries by way of realization of major energy savings and reduced CO_2 emissions as a result of implementation of measures as recommended under the project.

The consulting services ("the Services") shall entail providing maintenance support for the existing Knowledge web Portal of BEE that has been developed under the project. For the broad Terms of Reference refer to the "Tenders" topic on the web site of BEE (www.beeindia.gov.in).

The Bureau of Energy Efficiency now invites eligible consulting firms ("Consultants") to indicate their interest in providing the above-mentioned services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The information should include but not be limited to the following:

- (a) Experience in the design of web portals preferably for Government organizations in India including Public Sector Undertakings.
- (b) Experience in providing maintenance support for web portals (a) developed by the consulting firm, and (b) developed by third parties the experience at (a) and (b) preferably relating to provision of support to Government organizations in India including Public Sector Undertakings.
- (c) Experience in development of web content for Energy Efficiency / Conservation related industrial projects
- (d) Educational & Professional Qualifications of key personnel relevant to the assignment.
- (e) Experience of key personnel in designing web portals preferably for Government organizations in India including Public Sector Undertakings.
- (f) Experience of key personnel in providing maintenance support for web portals (a) developed by the personnel themselves, and (b) developed by third parties the experience at (a) and (b) preferably relating to provision of support to Government organizations in India including Public Sector Undertakings.

- (g) Technical and Managerial Organization of the Consultant (indicating the number of establishments in India, their locations, and employee strength at the respective locations). The Consultant should preferably have its presence in Delhi / National Capital Region (NCR).
- (h) Experience of the Consultant in working on projects financed by international agencies.
- (i) Turnover of Consultant (average of the last 3 years) for individual firms; combined turnover (average of last 3 years for JVs).
- (j) The business model of the Consultant, i.e. Commercial, NGO, Not-for-Profit, etc. along with documentary evidence thereof.
